On behalf of my father Jim, brothers Brian and Kevin and also on my own behalf I would like to express our sincere appreciation for the wonderful kindness and medical care and attention extended to my mother Margaret (Peg) during her time as a patient of yours and most particularly during her recent illness and subsequent passing

My mother was first admitted to your hospital under Dr. G. O'Sullivan in October 1994 and was subsequently transferred to the care of Dr. M. Madden when she was diagnosed with Non-Hodgkins Lymphoma. I fully believe that the excellent quality of care and attention she received at the hands of your medical and nursing staff enhanced her wellbeing, added to her lifespan and the length of remission from this illness. Earlier this year she had a recurrence of cancer and with the appearance of a Carcinoma in the neck/throat area was transferred to the care of Dr. Seamus O'Reilly and the team in St. Therese's Oncology Unit. From 7th March to her death in your care on June 4th she received the most wonderful treatment both from the staff of St. Therese's and also from the staff of St. Catherine's Ward.

As a family watching a loved-one suffering from this crippling illness it was so reassuring to know that she was given the absolute best of care and it was great to walk out of the ward at night with a light heart in the knowledge that everything that could possibly be done to make her comfortable in a physical, emotional and spiritual way was the endeavour of all your staff.

Mam bore her illness with great courage, grace and strength and we are very comforted by the fact that her suffering has ended and there is no more pain. Many years ago I heard a saying that "Cancer takes the sting out of dying" which made perfect logical sense, now from experience, I can appreciate the true value of this philosophy with the knowledge that she is at last free of all the physical and emotional burdens this illness brings with it and that she can bask in the fragrance of roses forever and help us to come to terms with our loss.

In this present climate when the Health Services are getting so much negative press from the media and where we as a society expect so much and take everything for granted, I just wanted to take a few minutes of your time to say Thanks and to let you know that you are all doing a fantastic job – please keep up the good work.

theatre project update

The current Theatre project is an ambitious one, which is phased over two stages.



Phase I of the project commenced in July 2005 and it will see an additional level sited on the roof of the existing building. A new link bridge was lifted into place during the course of the works and now joins the new fifth floor to the Sheares Street Block. This new fifth floor will be totally dedicated to the provision of facilities for Theatre staff and the anticipated occupation date is early November.



ten little fingers

National Guidelines for Hand Hygiene have recently been published (following consultation with a range of professional and non-professional groups) by the HSE, Health Protection Surveillance Centre (HPSC), as part of its remit under SARI (Strategy for the Control of Antimicrobial Resistance in Ireland). These Guidelines have now officially been launched by Ms. Mary Harney, Minister for Health and Children.

Our Chief Executive Officer, Mr. Patrick Madden, together with Mercy University Hospital's Executive Management Board, has given full support for implementation of these guidelines in addition to current good practice. The aim of the Guidelines is to highlight the importance of hand hygiene in preventing transmission of infection, and to promote the successful implementation of hand hygiene practices by healthcare workers, patients and the public.

Clear lines of responsibility and accountability are incorporated in these guidelines –

- Hand hygiene will become a standard of quality care in health care institutions. It has been promoted as an integral part of the quality of patient care, and is included in the standards for hospital accreditation and, is recognised as the single most important procedure for preventing infection.
- Each and every health care worker has a responsibility to prevent transmission of infection.
- Senior Health Care Workers such as medical consultants, nurse managers and managers in the allied professional groups, catering, domestic and technical services will act as role models and actively promote hand hygiene.
- Recommendations have been made that breaches in adherence to hand hygiene procedures should be addressed.

children first

'All organisations providing services to children have an overall corporate duty and responsibility to safeguard children'

Children First National Guidelines.

Children First is the set of guidelines which have been provided by the Department of Health and Children to help ensure the protection and welfare of children. They apply to all organisations which come into contact with children, including those which primarily provide a service to adults. This is a very wide remit and in the case of Mercy University Hospital includes, for example, not only children admitted to St. Anne's Ward but also children visiting their ill grandparent in a general medical or surgical ward. It also includes unseen children of a patient attending the Emergency Department following an episode of deliberate self harm.

To meet its responsibilities under Children First, a Mercy University Hospital Child Protection and Welfare Committee has been established. It is chaired by the Deputy CEO and consists of senior Consultant, Nursing, Human Resource and Support Services staff. A detailed nursing and medical protocol has been agreed and will be distributed through medical and nursing management. A more general staff information leaflet is in preparation.

Ms. Karen O'Mahony - Implementation Officer and Ms. Sinead Twomey - Information Officer with the Health Service Executive, have provided briefing sessions to the Heads of Department meeting and to groups of staff throughout the Hospital during September. The aim of these briefing sessions is to raise awareness among all staff, clarify roles and responsibilities and outline reporting procedures if any member of staff has a child



protection or welfare concern relating to a child known to the Hospital.

Further briefing sessions are being arranged and all staff are welcome and encouraged to attend.

cpi training programme

CRISIS PREVENTION INSTITUTE (CPI) TRAINING PROGRAMME

Mercy University Hospital has committed to becoming a CPI Non-Violent Crisis Intervention Training Programme Hospital.

The programme – Non-Violent Crisis Intervention Training, is a safe and non-harmful behaviour management system designed to help professionals provide for the best possible care, welfare, safety and security of disruptive, assaultive and out-of-control individuals even during their most violent moments.

The programme has been formally acknowledged by An Bord Altranais – The Irish Nursing Board – as Category One approved training and is also recognised by the Irish Office of Health Management. This mandatory programme will be rolled out to all Mercy University Hospital staff members and the Emergency Department has been selected as the first area to receive training.

It is envisaged that approximately 20 staff members will have completed the 'Train the Trainer Programme' by year-end 2005. These qualified Trainers will provide training for all

members of staff at Mercy University Hospital. Staff may obtain further information on the Mercy network H drive at: H:\CPI Information\Crisis Prevention Institute.


MRI service

The last few months have seen the MUH's Accreditation process begin in earnest. Each quarter we will keep you updated on what is happening via our Accreditation Diary.

TEAMS

Kieran Murphy has been appointed Accreditation Coordinator to oversee and supervise the project. The Coordination Team was completed in August with the appointments of Mary Barry and Siobhán Kenny, who will provide administrative support.

With the Coordination Team in place, focus then shifted to launching the crucial Self Assessment Teams. All of the Teams are now established, meeting weekly, setting up sub-groups and have already begun to compile data.

EDUCATION

The Irish Health Services Accreditation Board facilitated two in-house Education Sessions in early September for the Teams and the final Education Session is scheduled in October. Team members have found these sessions highly beneficial.

Information Sessions for staff were also held mid-September. As Accreditation is a process which will touch every level of our organisation, it is vital for staff to be as familiar as possible with the system.
